- AWINZ was founded in 1999 as a response to the Animal Welfare Act 1999 which was then going through the Committee stages of Parliament. AWINZ is one of only two organisations approved by the Minister of Agriculture under the Animal Welfare Act 1999 – the other being the RNZSPCA.
- AWINZ is a multi purpose charity whose functions include:

- Being a partner with Waitakere City Council in the delivery of animal welfare compliance services.
- Administering the New Zealand Fund for Humane Research (the Lord Dowding Fund), which provided \$10,000 funding to Unitec for research into the use of animal mannequins in teaching, and \$25,000 to Massey University for leading edge computer modelling of the veterinary anatomy museum.
- Being the only New Zealand organisation providing independent monitoring of animal use in movies including The Lord Of The Rings, The Lion, The Witch And The Wardrobe, The Bridge To Terabithia.
- Assisting in the funding and organisation of conferences including the ARLAN/AWINZ/Unitec Workshop on animal welfare law and enforcement.

#### Adjunct Professor, The Humane Society University

- A collegial alliance of universities collaborating on international e-learning in certificate partners includes Jones International University, Johns Hopkins University (Baltimore), University of Missouri (Columbia), British Columbia University (Vancouver), National University of Costa Rica (San Jose), Trinity College (DC), Oxford University (UK) and Unitec.

- Wrote the Hodgson Bill in 1997 and then engaged by Parliament to advise the Primary Production Select Committee on detail of both the Hodgson Bill and the Government Animal Welfare (No 2) Bill, which was subsequently enacted as the Animal Welfare Act 1999 — (see *testimonial from Hon Pete Hodgson*).

#### First Strike Campaign

- In 2001 brought Dr Randall Lockwood to New Zealand for the first seminar on the relationship between childhood animal cruelty and violence in society generally. That has led to the spearheading of a consortium of welfare agencies (CYFS, Police, women's refuges, SPCA), which continues to explore ways to promote the connection and to initiate research.

#### World Society for the Protection of Animals: Regional Director (South Pacific)

- Set up the South Pacific Regional office and worked throughout the South Pacific on relief projects and establishing core organisations in the Pacific nations

#### Consultant to the Singapore Government

- Reviewed operations of the Department of Primary Industry and reported, with recommendations, on restructure of urban animal management.
