## Privacy Act Request and Official Information Act Request

This letter is in response to your emails of 30 and 31 October 2011.

In your email of 30 October you have asked a number of questions, which I will answer in turn:

1. All documents relating to the review which you undertook including any documents in which you report your findings.

Officials prepared a Report outlining the chronology of MAF's relationship with you and Verisure Investigations Ltd. This is withheld under section 9(2)(g)(i) of the Official Information Act. Section 9(2)(g)(i) provides good reason to withhold information if, and only if, the withholding of the information requested is necessary to "maintain the effective conduct of public affairs through ...[t]he free and frank expressions of opinions by or between .... officers and employees of any department... in the course of their duty" and the need to withhold information is not "outweighed by other considerations which render it desirable, in the public interest, to make that information available".

It is essential that the chief executive of MAF be confident that the advice received for decision-making is unimpeded by the threat of it being released under the Official Information Act and published on the web to the world at large. Officials need to be confident to be able to provide advice in a free and frank manner so that the decision-maker is able to make an informed decision. There are no considerations which outweigh the need to withhold the information. All factual material in the Report is also on your website. You have that information. The decisions of the judges in the court cases between you, Verisure Investigations Limited, and Neil Wells are in the public domain.

2. Any anti-corruption policies MAF has pertaining to investigations and audits. This request is refused under section 18 (e) as there is no such information.

3. Procedure documents which outline the verification process adopted for ensuring that MAF trades with real entities as opposed to fictional names.

This request is refused under section 18 (e) as there is no such information.

- 4. Documents outlining procedures which are available to the public when they are questioning the existence of an approved organization.

  This request is refused under section 18 (e) as there is no such information.
- 5. Documents which relate to procedures for the protection of whistle-blowers and manner of dealing with whistle-blowers.

  Please find attached the MAF Whistle-Blower policy. Note it relates solely to MAF employees and is not applicable to complaints received from members of the public.
- 6. Policies with regard to Cronyism (page 33 of the document) and management of conflict of interest.

The first part of the request relating to policies on Cronyism is refused under section 18 (e) in that there is no such information. The MAF policy on Management of Conflict of Interest is attached.

7. Policies for investigation of complaints, in particular covering aspects which would explain why I was investigated in depth for allegedly passing myself off as a MAF officer (a complaint made by persons who are now convicted fraudsters) and why a similar investigation was not conducted into the existence of AWINZ.

MAF is not able to process this part of your request within the 20 working days permitted under the Act. While it is intended to release information to you it will take longer to collate and assess. MAF will charge you for this information before it undertakes any further work in respect of this particular request. A deposit from you paid in advance will be required. The time to respond to you more fully on this request as to how much the deposit will be is extended until 8 December 2011 under section 15A of the Official Information Act. Once you are notified of the cost no action will be taken by MAF until the deposit has been paid.

Should the work required be less than the deposit the remainder of the deposit will be returned to you. In the event that the cost is greater MAF will require you to make further payment and will require your agreement to incur more cost before further work is undertaken. The charges will be based on the Ministry of Justice 'Charging Guidelines for Official Information Act 1982 Requests' available on their website at <a href="https://www.justice.govt.nz">www.justice.govt.nz</a>.

8. A copy of all correspondence to Mr Wells and any of the alleged trustees of AWINZ with regard to withholding the audit report from me.

Please find copies attached. Note there is one minor deletion made under section 9(2)(g)(i) for the same reason as is set out in paragraph 1 above.

9. Documents which prove or show that you have investigated and were satisfied that Tom Didovich, Wyn Hoadley, Graeme Coutts and Neil Wells were together the approved organization.

This is refused on the basis that any such information related to the request has been supplied to you previously. There is no information relating to AWINZ that could be released to you that has not been already released to you.

You have also requested information in your email dated 31 October. In that email you requested "...all information which you have collated and hold on me including notes, recordings, reports, jottings letters, transcripts, made available according to Privacy Principle 7"

MAF has no information other than which was made available to you in 2007 by Jockey Jensen in his letter of 4 October 2007. Please see copy attached.

And at the end of the 31 October email you requested:

"....all documents whereby it was decided to investigate me for the alleged passing off as a MAF Officer, I would also like the documents which would support the views which were expressed at that time that this was a serious matter and I would also like to know on the same basis as to why a non-existent law enforcement authority (approved organization) is not a serious matter. I am particularly interested in any documents which show Mr Wells' involvement in getting MAF to investigate this matter"

All relevant material has been made available to you. Mr Wells had nothing to do with the investigation into the alleged passing off as a MAF Officer.

You have the right under section 28(3) of the Official Information Act to request that an Ombudsman investigate and review this decision to withhold information and to charge you for the release of information. A request must be made in writing to:





Dear Sir.

Thank you for your warning dated 31 August 2007. A warning would be like water of a ducks back to many people but unfortunately in my position. I take warnings very seriously as it effectively means that you believe that I am a liar as well as some one who passes themselves of as something they are not.

I note that you state that a Prima Facie case has been made out. Could you please forward the evidence which provides you with this Prima Facie evidence and all documents, notes correspondence, reports, emails, directives and jottings which, relate to this complaint. I believe that a copy of this can be made available to me under the official information Act.

These people are liars and it comes to their word against mine (an ex Police officer of 15 years service and now a Licenced private Investigator) you apparently believe them and not me despite the fact that they were using their premises as a transitional facility in the name of a company which they claim they had no involvement with.

You may wish to contact the ministry of economic developments and speak to PJ the investigator there who is dealing with the bogus liquidation of the company that these people, who you believe in preference to me, ran, the certificates of which were on the wall declaring them to be a Transitional facility when in fact that company had seased trading.

To clarify this I point out that the company which was run by Pryor was allegedly sold to a non existent person Sanjay Patel in November 2006. Sanjay used the address as his residential address. He liquidated the company and the lease of the premises remained in the name of Fresh prepared Ltd.

Salad foods run by Lyn Pryor operated from the premises taking over the business seamlessly from fresh prepared Ltd, but fresh prepared MAF Certificates continued to hang on the wall. No MAF certificates in the Name of Salad foods were seen. I brought this to the attention of your investigator and as such lask for all documents, notes correspondence, reports, emails, directives and jottings, and the result of the enquiry into the use of this transitional facility to be also made available to me under the official information act.

A further question under the official information act is how: it can be a transitional facility when the company that has the licence no longer operates from these premises? It should be noted that the very people who have reason to tell lies are believed and the person who had every right to call on the premises to locate Mr Sanjay Patel, is accused of all sorts of things and is harassed in every possible way by the owner of Salad foods Terry Hay who even swore a perjurous affidavit to obtain a court order see <a href="http://www.verisure.co.nz/FreshpreparedItd.htm">http://www.verisure.co.nz/FreshpreparedItd.htm</a>) and who placed three advertisements to ensure that I was over run by Chinese callers both on my phone and at my house.

Lask you to reconsider the warning and ask that if you have such faith in your prima-facie evidence that you offence so at least I can clear my name in court, my reputation and my truthfulness is very important to me and I believe that this is a slur on my integrity and credibility.


