Dear Grace

Emails to elected members and other council staff are often filtered to ensure the most efficient use of their time and to ensure that council resources are applied to best effect.

Councillors, for example, have dedicated support staff who manage their emails on a daily basis. All of the elected members and senior council staff to whom you write receive large volumes of emails every day. In this situation emails from you to the various and numerous addressees have been blocked to all council addresses except my own since November 2012. You were advised at that time that all correspondence from you will be retained in council records but no reply will be sent. This applies also to all LGOIMA requests, in respect of which a failure to reply is a deemed refusal that may be referred to the office of the Ombudsman by way of complaint.

Please note that there is no legal requirement for emails sent to a council email address to be delivered unfiltered to that or any other particular email address; any email sent to an elected member's email address or any other council officer may be treated as having been received by council for LGOIMA and other official purposes.
