

## TOP SECRET INVITATION LIST WIDENS BUSINESS- GOVERNMENT CHASM

The South Island business community fears it has little representation at the government's upcoming business forum.

It is the latest group to add its voice to complaints the occasion will not put across typical business views by excluding those critical of government policies.

But those who are invited - including some corporate heavyweights - say they hold high hopes for the talkfest.

Those The National Business Review spoke to have identified both a national strategy and R&D at the top of their agendas.

The invitation list of about 80 business heads has so far been kept secret by Prime Minister Helen Clark.

It does include some Business Roundtable members - such as Ports of Auckland chief executive Geoff Vazey, previously outspoken on the government's labour law but now keeping shtoom - as well as frank lobbyists such as Trevor Eagle of Eagle Technology, accountants, bankers, exporters and manufacturers.

But the uninvited "B Team" - including the majority of the Business Roundtable, chairman Ralph Norris and executive director Roger Kerr, business association heads and an apparent paucity of businesspeople south of Christchurch - has raised the ire of others.

The Tuesday, October 24 event, to be hosted by law firm Buddle Finlay in Auckland, is expected to be an informal chat rather than a speechmaking day.

Attendees have been told they will break into discussion groups with Ms Clark and ministers such as Jim Anderton, Michael Cullen, Steve Maharey, Phil Goff and Paul Swain.

The buzz words of the day will be the "new economy," taxes, and policy issues such as export assistance and tax write-offs for research and development.

In the South Island, concern is mounting at the apparent lack of representation. Sir Gil Simpson is on the invitee list - although his office will not confirm his attendance - and the Prime Minister's office said 10 other southerners would be going.

But both the Canterbury Employers' Chamber of Commerce and the Otago chamber know of no invitees past Christchurch. Their concern builds on regional disquiet after no one south of Christchurch was appointed to the government's science advisory board or Industry New Zealand.

"I think they have forgotten we exist or that there is a South Island," Otago chamber chief executive John Christie said.

Canterbury Employers' chief executive Peter Townsend said he intended to hold a South Island meeting to discuss the forum's outcomes and report to the government.

EMA Northern chief executive Alasdair Thompson resorted to applying under the Official Information Act for the list of names but was refused. He and other association heads cannot understand their exclusion.

"The PM has repeatedly threatened to sideline or punish people and business organisations who have spoken out against certain government policies. She is out of order," Mr Thompson said.

Those not invited say the real test will come after the forum, when and if any policy changes are made.

Sky chairman and attendee Nate Smith wants to discuss the falling dollar and its impact on multinational companies such as his own.

Eagle Technology founder Trevor Eagle wants to see a national strategy of "where we are going" formed. He also wants to discuss research and development policies and the possibilities of introducing venture capital schemes such as the Israeli model.

X-Sol founder John Blackham said he thought R&D tax issues could be a red herring.
