Affidavit of Greg Reid in support of application for disposal orders pursuant to Animal Welfare Act 1999.

Introduction

 Lam swearing this affidavit in support of an application for disposal orders (under section 136A of the Act) in relation to dogs seized during an inspection

In this affidavit I will set out the costs to SPCA Auckland in relation to caring for these seized dogs.

Costings

- Each dog seized and dogs born to those seized dogs at the SPCA all have individual records. Each
 record holds each dog's details and have been kept up to date including vet checks, diagnostic results,
 temperament and behaviour.
- Board is broken into two charges:
 - \$15 per day when housed at SPCA, this includes daily kennelling, cleaning, socialisation, enrichment, training and general care.
 - \$30 per day when housed with an SPCA approved Foster Family, this includes daily cleaning, shelter, foster supplies (crates, collar, leads etc) socialisation, enrichment, training and general care.
- Vet costs consist of any internal veterinary care/medication, diagnostic testing, external veterinary care/medication and diagnostic testing.
- As an estimate Resting Energy Required (RER) was used to calculate total cost of food to SPCA if purchased at retail price.
 - Dogs over 18 months: \$2.80 per day. Dogs 6 18 months: \$2.11 per day.
 Dogs 3 6 months: \$3.33 per day.
- Two dogs were pregnant on arrival to SPCA and gave birth to puppies while in SPCA care. Both litters
 received supplementary feeding due to the dam's inability to fully independently feed. The cost of
 supplement milk powder for puppies, Superlac, was a one-off additional cost of \$179.40
- Board costs and Vet costs for the adults commenced the day of entry. Although these costs are ongoing.
 for the purposes of this affidavit I have completed the calculation

Calculations

- Vet costs as per each SPCA record \$28,914.49. This cost include treatments (Vaccinations, de-fleaing, de-worming), multiple whe veterinarian care after hours and diagnostic testing.
- Board costs from entry date till 31 May 2018: Days in the shelte SPCA record.
 - Board SPCA = \$36,225.00
 - o Board Foster = \$81,660.00
- Food costs = \$14,599,22

Total costings as at 31 May 2018:

o Adults + Litter 1 + Litter 2 = \$161,398.78

The costs for this case will be well over \$700.000.



SPCA Inspectors have been working on this investigation for several months.

"It was definitely a 'thank God'
moment. You live with the fear that the
case won't go well and I'd have to call
all these people and tell them that the
dogs they were so invested in and loved
so much had to be returned."

"Can you imagine having to send those dogs back to that place? That's something I'd never want to do."
